## **CONFIDENTIAL INFORMATION AND PERSONAL DATA PROTECTION**

Compliance Control Limited (hereinafter – Compliance Control Ltd.) during your Personal Data processing is guided by the provisions of current legislation on the confidential information and personal data protection, respectively, including the Law of Ukraine "On Personal Data Protection", the Law of Ukraine "On Advertising", the Constitution of Ukraine and other legal acts of Ukraine. Any information provided while using this site or in connection with other requests to Compliance Control Ltd. relating to personal data will be used only for the purposes set out below.

Personal data may include, in particular: identification data (surname, name), address of residence, postal code, contact telephone number, date of birth, e-mail address.

By providing Compliance Control Ltd with your Personal Data, you give your voluntary and unconditional consent to the processing by Compliance Control Ltd, as well as you confirm the fact that the relevant information is not confidential and may be stored and used by Compliance Control Ltd in the personal database to processing incoming requests, communication with the Users; rendering information services, including distribution of advertising and information materials; carrying out marketing, statistical and other researches.

In particular, you also give your consent to Personal Data processing (including the collection, registration, accumulation, storage, adaptation, modification, renewal, using, and distribution), depersonalization, destruction, including using of information (automated) systems, transferring of the provided Personal Data (without obtaining your additional consent and without additional notification of such transfer), including cross-border, receipt of marketing materials, mailings within the advertising campaigns of Compliance Control Ltd.

The Personal Data processing may be carried out by Compliance Control Ltd itself, or the right for such processing may be transferred by Compliance Control Ltd to third parties (hereinafter - "Administrators").

You give you consent to:

- the Personal Data provided will be used by the Compliance Control Ltd and the Administrators for the above-mentioned purpose in accordance with the current legislation of Ukraine.
- the Personal Data provided may be distributed (transferred) by Compliance Control Ltd for the above-mentioned purpose to Managers and third parties to whom Compliance Control Ltd will be obliged to provide Personal Data in accordance with applicable law;
- your Personal Data will be deleted or destroyed in the manner prescribed by Article 15 of the Law of Ukraine "On Personal Data Protection". Access to Personal Data will be carried out in accordance with the Law of Ukraine "On Personal Data Protection".

The Personal Data processing and storage are carried out during the time that necessary to achieve the above-mentioned purpose.

Please be informed of your rights under the Art. 8 of the Law of Ukraine "On Personal Data Protection" such as:

- to know the location of the personal database containing your personal data, its purpose and name, location and/or place of residence of the owner or manager of this database or give a corresponding order to authorized persons to obtain this information, except as provided by law;
- to receive the information on the conditions for granting access to personal data, information on third parties to whom your personal data, contained in the relevant personal database, are transferred.
- to have the access to your personal data contained in the relevant personal database;
- to receive no later than 30 calendar days from the date of receipt of the request, except as provided by law, information on whether your personal data is stored in the relevant personal database, as well as receive the content of your personal data stored;
- to make a reasoned request with an objection to the processing of your personal data by public authorities, local governments in executing their powers under the law;
- to make a reasoned request to change or destroy your personal data by any owner/administrator of this database if this data is processed illegally or is inaccurate;
- to exercise the right of protection of your personal data from illegal processing and accidental loss, destruction, damage due to intentional concealment, non-provision or untimely provision, as well as prevent the provision of information that is inaccurate or discredits the honor, dignity and business reputation of individual;
- to apply for the right of personal data protection to public authorities, local governments, whose powers include the protection of personal data;
- to apply legal remedies in case of violation of the legislation on personal data protection.
